1. OBJECTIVES:

1. To impart and promote General, Technical and professional Education including Arts, Commerce, Science, Industries, Agricultural, Engineering, Medicine, Law and Fine Arts for Boys and Girls irrespective of caste and creed.
2. To establish Schools, Colleges, Educational Institutions, Technical, Professional, Crafts, Music, Fine Arts and others in various Languages.
3. To establish Elementary, Middle and High Schools and Technical Schools and gets the same recognized by the Government wherever and whenever necessary or occasion arises.
4. To get the schools, colleges and other institutions recognized by the concerned state Government and get affiliation to the concerned Universities or any other University, and also seek affiliation to the Central Board of Secondary Education (CBSE), as per the rules and regulations of the concerned Government or Universities and CBSE etc.
5. To establish Libraries, Laboratories, Workshops and such other facilities that are necessary to carry out the objects of the society
6. To start hostels, for providing boarding and lodging to the students and other deserving individuals at such fees structure as the executive committee may decide and fix and arrange canteens, and stalls to supply food supplements if feasible at subsidised rates.
7. To honour Pundits, Scholars, literates and other efficient and prominent persons of any field to encourage literary, art, cultural and sculpture work etc and to promote Publication of books, literature and brochures and conduct Research works and provide sufficient facilities therefore.
8. The amounts relating to fees, subscriptions, donations, grants, gifts, movable or immovable properties shall be treated as sources for finance. Such funds shall be spent only for the attainment of the objects of the Society and no portion thereof shall be transferred directly or indirectly to any of its members through any means. The funds of the Society shall be invested as per sec-11(5) or any other provisions of the Income Tax Act, 1961.
9. To apply and receive grants, aids and sponsorships from the concerned governments and universities and CBSE and maintain them in accordance with the rules and regulation connected therewith.
10. To create and maintain Discipline, Self-Confidence, Trustworthiness, Loyalty, Honesty among the people at large and the students in particular
11. To maintain unity, Co-operation National Integration and Social Customs among the members of the Society.
12. To promote universal brotherhood among the people irrespective of their Race, Religion, Caste, Community and Sex.
13. To establish colleges pertaining to Homeopathy, Ayurvedic and other similar medical colleges and also schools and institutions to impart education in Vedas, Yoga and other similar institutions.
14. To take up all kinds of charitable works and promote health and harmony between people irrespective of cast and creed.
15. To do all such things which will help the attainment of the objects of the Society.

4. MEMBERSHIP

- a) **Eligibility** : The membership shall be open to all who are interested in promoting the objects, rules and regulations of the society subject to the approval of the President Cum Correspondent. The area of Operation of the society shall be throughout India, in particular at such places, where the society wants to establish
- b) **Admission** : Any person who wants to admit himself as member shall pay an amount of Rs 20,000/- towards subscription, which shall be a one time payment. Any person wishing to become a member shall submit an application in the prescribed format together with all bio-data including a copy of the "Aadhar card". Such properly filled in application shall be placed before the President cum Correspondent, whose decision shall be final, regarding the admissibility or non-admissibility of such intending member.
- c) **Termination of membership** :
- (1) Who resigns in writing;
 - (2) Who fails to attend three consecutive meetings;
 - (3) Who were expelled by the president Cum Correspondent, on the ground of violation of the rules and by-laws of the society or who acts detrimental to the interest of the society, or on the ground of indiscipline, etc

Any member whose membership is thus terminated, shall not be entitled to refund of the amount paid by him while joining as member.

5. GENERAL BODY

- a) **Meetings** : The General Body meeting of the society will be held in the month of MAY every year. The General Body shall meet at least once in a year.
- b) **Quorum** : The quorum for General Body meeting and Executive Committee meeting shall be 1/3rd of the total members. In case such quorum is not available at the time and place mentioned in the notice, the meeting shall be postponed by one hour, and such adjourned meeting shall not require any quorum.
- c) **Functions and Responsibilities** :
- (1) To elect and confirm the Executive Committee;
 - (2) To pass the Budget and approve the Annual report;
 - (3) To appoint an Auditor to audit the accounts of the society;
 - (4) To transact any other matter for the benefit of the Society.
- d) The General Body shall elect the Executive Committee members once in 3 years.
- e) The General Body has power to remove any member of the Executive Committee.
- f) The executive committee formed at the inception of the society shall hold office for a period of three years.

6. EXECUTIVE COMMITTEE :

The Executive Committee shall consists of 9 members, i.e., President cum Correspondent, Vice President, Secretary, Joint Secretary, Treasurer and 4 Committee members. Any interim vacancy in the Executive Committee shall be filled up by the president cum Correspondent from out of the general body of members. Any person so appointed during the interim vacancy shall function for the remaining part of the period.

Any member, who has completed a term as an elected member to the executive committee, is eligible for re-election as a member of the Executive Committee. The Executive Committee shall meet once in Three months. The Executive Committee shall convene a general body meeting within 30 days of receipt of a requisition for convening a meeting signed by at least 3/5ths of the members of the society and any such requisition shall contain the proposed agenda and the reasons for such meeting. Every resolution of General Body and Executive Committee shall be recorded in the minutes book. Such minutes shall be communicated to all the members invited for the meeting within 30 days. The minutes so recorded shall be signed by the person who chaired the said meeting.

Co-opted Members:

The Executive Committee have the power to co-opt two members in addition to the elected members. The co-opted members need not be members of the General Body and they shall not have the voting power.

7. RESPONSIBILITIES OF OFFICE BEARERS ::

PRESIDENT CUM CORRESPONDENT:

He shall preside over all the meetings of the Society. He shall have casting vote in case of tie in the meetings. He will keep the best contact with the Society, it's members and at large with the day to day functions of the society. He shall closely watch and administer the activities of the society and take suitable measures and steps where and when ever necessary. He will be the Chief Supervisor and controlling officer of the society. He shall be the constitutional head of the society. He shall have the following powers.

- a) To fix the remuneration and allowances to the employees, to appoint, dismiss, suspend or otherwise punish any employees of the society.
- b) To accept the resignations of members
- c) To sanction all the contingent expenditure relating to the society
- d) To deposit the funds of the society in any reputed bank
- e) To borrow money from the Nationalised Banks, Co-operative Banks, Private Banks, Post Offices, other organisations or individuals and for that purpose give the property of the society as security.
- f) To take on lease such movable or immovable property on lease to attain the objects of the society.
- g) Inspect the accounts of the society periodically and transact any other matter for the benefit of the Society.
- h) All transactions of the society shall be carried out in the name of the President cum Correspondent. The entire establishment of the Society shall be under the immediate supervision and control of the President Cum Correspondent.
- i) He will attend to day to day correspondence work of the society
- j) Bank transactions & Cheques for withdrawal of funds shall be signed by the President cum Correspondent only.

VICE PRESIDENT ::

He will assist the President cum Correspondent in the day to day activities of the society. In the absence of the President cum Correspondent he shall attend to the duties of the President cum Correspondent and preside over the meetings.

SECRETARY ::

He shall convene all the meetings of general body the society and executive committee, and record the minutes in the minutes books of the general body meetings and executive committee meetings separately. He shall be responsible for carrying into effect, the resolutions of the General Body as well as the Executive Committee. He shall maintain proper records of the society and keep them safe and open for inspection by any member of the society. He shall prepare the Annual report of the society and place the same before the Annual General Body meeting for approval.

JOINT SECRETARY :

He shall carry out the instructions of the Secretary from time to time and assist him all his duties in the absence of the Secretary.

TREASURER :

The Treasurer is to keep the regular accounts of Income and Expenditure of the Society. He will prepare the annual budget of the society under the supervision of the Secretary and place it before the Annual General Body meeting for approval.

COMMITTEE MEMBERS ::

They will attend to the activities of the Society, and strive for its development, and shall attend to such duties as are allotted to them from time to time by the President cum correspondent.

8. **FINANCES - FUNDS :**

The amounts received as subscriptions, donations, grants, gifts of movable or immovable properties shall be treated as sources of finance. Such funds shall be spent only for the attainment of the objects of the society and no portion thereof shall be transferred directly or indirectly to any of its members through any means. The president cum correspondent shall be in overall charge of the said funds and properties.

9. **MORTGAGES & CHARGES :**

The Society shall keep a register of mortgages and charges and enter therein all mortgages, charges affecting the property of the Society and be open during the business hours to the inspection of any member or creditor of the Society without payment of any fee therefore. Any debts or liabilities relating to the Society will be settled by the President cum correspondent after consultation with the executive, and be decided by a separate resolution.

10. **DISPUTES :**

In the event of any disputes, arising among the members of the executive committee or the members of the Society, in respect of any matter relating to the affairs of the society, it shall be resolved as per the provisions of The Andhra Societies Registration Act, 35 of 2001

11. **DISSOLUTION :**

If for any reason the society will have to be dissolved. It shall be approved through a special resolution. If upon the dissolution of any Society, there remains after the satisfaction of all its debts and liabilities, any property, the same shall not be delivered to or distributed among the members of the society or any of them, but shall be delivered/transferred to some other society/body with a similar objectives to be named by a special resolution, or in default thereof, by the court subject to the conditions mentioned in the sections 24 & 25 of the Act. The transferee Body has been recognized by the Income Tax Authorities as registered under section-12A of the Income Tax Act, 1961 or as per any provisions of the said Act.

12. **AMENDMENTS :**

By a special resolution, the Society may alter the provisions of the Memorandum and Bye-laws i.e., 1) Change of objective of the Society 2) Change of name of the Society 3) Amalgamate itself with any other society, or of 4) to divide itself into two or more societies subject to the provisions of the Act and conditions contained in the Memorandum of Society may by an Ordinary resolution passed by 3/5ths of the members present and voting for alteration of the bye-laws. Any amendment shall be made with the prior approval of the concerned commissioner of Income Tax (Exemptions) or such authority as may be designated to be the authorized officer to allow such permission under the provisions of Income Tax Act 1961.

- (1) Change of objectives of the society or add such objectives, which will not disturb the main objects of the society.
- (2) Change the name of the Society.
- (3) Amalgamate itself with any other society.
- (4) To divide itself in to two or more societies subject to the provisions of the Act 35 OF 2001.

Meeting convened for such purpose shall be governed by Clause 5(b) above.

13. **MANAGEMENT :**

A Society shall have registered office to which all communications and notices may be addressed. Any change of its registered office to a place outside the District in which it is registered shall be intimated to the Registrars of both the Districts.

14. **DISQUALIFICATION OF MEMBERS :**

- a) Not a major
- b) Unsound mind and stands so declared by a competent court
- c) Adjudicated as an insolvent or is an undischarged insolvent
- d) Disqualified for such appointment by an order of court
- e) As per rules of the Act 35 of 2001 and other reasons

15. **SUITS :**

- a) The Society shall sue and be sued in the name of the President Cum Correspondent.
- b) Court Jurisdiction :- All the legal affairs of the Society shall be settled in the jurisdiction of District Court, Eluru.

16. **PROPERTIES :**

The Properties movable or immovable shall vest in the name of the Society and shall be represented by the President Cum Correspondent.

17. **AUDIT :**

The Annual accounts will be audited by Authorised Auditor qualified as Chartered Accountant at the end of every financial year and circulate the same among the members.

18. **FINANCIAL YEAR :**

Financial year means a period of 12 months from 1st April to 31st March of next year or the financial year as directed by the Government.

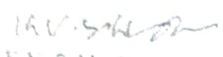
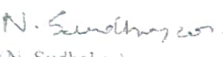
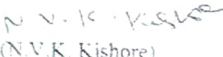
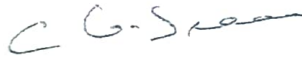
